HOMEOPATHIC MEDICINES

In the United States homeopathic medicines are a federally recognized form of medicine.

In the United States the regulation of homeopathic medicines, including single remedies, combination remedies, and non-prescription homeopathic products sold in pharmacies, retail outlets and online, is governed by the federal Food, Drug and Cosmetic Act of 1938, as amended (21 U.S.C. ch. 9 § 301 et seq) (FD&C Act). That Act is enforced by the U.S. Food and Drug Administration (FDA). Section 321(g) of the FD&C Act defines a drug as, “articles recognized in the official United States Pharmacopoeia, official Homoeopathic Pharmacopoeia of the United States, or official National Formulary, or any supplement to any of them.”

The vast majority of homeopathic medicines are available over-the-counter to consumers.

SCOPE OF PRACTICE

Colorado is one of eleven states with so-called “health freedom laws” also referred to as “safe harbor exemption laws”, which include the practice of homeopathy. Colorado and the United States do not have official licensure options for homeopathic practitioners.

Generally speaking, these “safe harbor laws” allow unlicensed practitioners of homeopathy (and other natural, alternative, complementary and integrative healing arts) to practice in accordance with the following disclosures.

Therefore, please be advised: I do not practice medicine. I am a homeopathic practitioner and consultant, and am not licensed, certified or registered by the State as a Health Care Professional.

I do not diagnose, treat, prescribe for, palliate, or prevent any human disease, ailment, pain, injury, deformity, or physical or mental condition, whether by the use of drugs, surgery, manipulation, electricity, telemedicine, the interpretation of tests, including primary diagnosis of pathology specimens, images, or photographs, or any physical, mechanical, or other means whatsoever.

I am not in the practice of suggesting, recommending, prescribing, or administering any form of treatment, operation, or healing for the intended palliation, relief, or cure of any physical or mental disease, ailment, injury, condition, or defect of any person. I do not examine or treat persons afflicted with disease, injury, or defect of body or mind.

I am not an M.D., D.O., physician, surgeon, or any other word or abbreviation that might indicate or induce others to believe that I am licensed to practice medicine in this or any state.

I do not advise clients to discontinue any medication they may be taking without first discussing it with his or her doctor.

I am an 'Intuitive Homeopath'. I consult with and educate clients in the selection of homeopathic medicines to administer to themselves and/or those under their care.

BILLING DISCLOSURE

The No Surprises Act / Good Faith Estimate of Charges for Services—

My fees are as follows:

\$50.00 — One session/one day; may include one remedy, or a few in a row, as called for.

\$120.00 — Three days in a week; see above. To be coordinated based on our schedules. The three days must be used within a seven day period.

\$400.00 — One month; includes weekly check-ins. Again, the number of remedies/days will depend on what is called for. This is not all day, everyday during the month, but as needed. If you have something going on, you can send me a picture. And you will remain on my 'radar', so I will reach out to you during the month if I pick up on something. This is also a good option if you are interested in working deeper.

Fees are due at the time of service. No post-session billing will be permitted. I accept direct transfer by Venmo, Paypal and Zelle. Contact me to discuss other methods of payment. (See the end of this document for payment links.)

Hours of Operation (Eastern Time Zone):

Monday- 12pm to 2pm

Tuesday- 12pm to 2pm

Wednesday- By appointment only

Thursday- 12pm to 2pm

Friday- By appointment only

I do not work on weekends.

These are approximate hours to illustrate that the windows in which I am focusing on cases are limited. Actual hours may vary. I may, and probably will, message you at other times, outside of the above listed hours.

Note: We are not meeting at a set appointment time, so you do not have to be available during the times listed above. We will be communicating by email and/or the Signal messenger app. (However, you may want to reference your time zone and my hours of operation if you trying to estimate when I will get back to you, if you are waiting.)

Response time: Once we are connected, you often will get the remedy name and potency from me right away. But in some cases I need time to ‘sit with it’. I always do my best to communicate clearly what to expect.

I am not an emergency medical provider. Just like with most practitioners, I work within regular hours. I also have to manage my energy in order to be able to provide this service for others.

If you require **weekend** or rushed ‘**emergency**’ support, **the rate starts at \$500.**

If this still interests you, begin by emailing me the necessary paperwork with a current photo and details so I can assess and we can discuss a rate. (Refer to the ‘process’ section below.)

(If you know you will be needing acute help, it is preferable to schedule three days in a week, or a month of support, and you will get much more for the money!)

In case of a true or suspected medical emergency, please go to the hospital or seek the appropriate urgent care.

I do not work with insurance. In the US it is not standard practice for insurance companies to reimburse for homeopathic and other ‘alternative’ treatments.

Clients are responsible for having a Bionetix Vitalis homeopathy imprinting device, or similar, or the Twisted Tensor app.

If you do not want to purchase a device, or use the TT app, you may choose to have the remedies broadcast to you remotely via a Vitalis or the TT app for an extra charge. (See below for details.)

Virtually *any* remedy and potency might be called for, and many are not even available to purchase. Shopping for and purchasing every remedy **is not an option** as part of this process.

Additional fees to have the remedies broadcast to you:

\$20.00 — for the first broadcast

\$5.00 — for each additional broadcast on the same day

(Each day these rates reset.)

These additional fees, if applicable, will be paid separately to **Dawn Spain** via by Venmo or Paypal. See the end of this document for payment links.

Dawn Spain is an associate with Roaring Fork Homeopathy and acts only as an assistant in cases where the client does not have the homeopathic remedy on hand or have a device. She is operating at arm's length from your transaction with me, and only requires a photo (one time) and the remedy and potency in order to broadcast what you would otherwise do yourself. She is not offering treatment, and does not claim to be practicing medicine, and she operates with no knowledge of our communications. She will only be told by me which remedy and potency to broadcast.

THE PROCESS AND IMPORTANT GUIDELINES

Please keep this document as a reference for rates, payment and procedures.

Very important: Please read this document IN FULL.

If you haven't already, please read over my information at <https://roaringforkhomeopathy.com/sharon-hicks/> regarding what my work does and does not address. For example, I am not taking requests regarding your specific ailments, and I am not a 'medical medium'. Often this work *will* help current conditions, but we can't know specifically what or how in advance.

STEP 1:

To start the process with me, please **review this informed consent document** in full.

Then sign it, date it and **email to me at sharon.h@runbox.com**.

(You may sign it digitally, or print and sign. If you aren't able to scan, you may take photos of these pages and email the images to me.)

Note: We can continue to communicate by email, or we can chat using the Signal Messenger App. If you prefer messaging, please set up the app on your device and then **email your phone number to me** and I will connect us.

Include a photo of the subject in your first email to me.

What type of photo? Preferably taken right then, eyes open, no glasses, no hat. (These are *not* posed photos, but honest, open and real-time selfies. Your hair and makeup are not important.)

And please let me know if you are using the Vitalis, the Twisted Tensor app, or would like Dawn to facilitate. (Links to these devices are provided above. You can change this at any point, but it helps me so that I can know which details to give you for the remedies.)

Also include name, birthdate and location (City and State). These are in case you need the remedies to be broadcast to you at some point.

STEP 2:

I will respond to you. And I will let you know when I can begin. If I already have many clients lined up, we will coordinate schedules.

Then this is the process:

- You send me a current photo.**
- I tell you what remedy and potency to self-administer.**
- You send me a new photo, freshly taken.**
- We repeat this process as needed until ‘complete’ for the time being. This may require one remedy, or a string of them in a row.**
- At each step you must send me a new photo.**

Feedback: Feedback at each step is always appreciated and helpful.

Are you (or the subject) feeling a new or different emotion now? Are you experiencing a physical sensation anywhere in the body? Are you feeling calmer? Feeling tired?

- If you are doing multiple days with me, you will need to send a new photo each day, and the process repeats.
- There will be times when a remedy needs to continue working for a while. *In which case there is nothing more to do at that time.*

- At other times, multiple remedies will be required in succession.
- Occasionally, you may be told to repeat a remedy according to a certain frequency.

Please follow the directions.

- **All remedies are to be taken ONE time only, unless told otherwise.**

Sometimes, when people feel fantastic, they want to take extra. Please don't. This can lead to aggravations.

You may not feel anything noticeable. That does not mean you should take more. You will simply send me another photo.

It's possible you will feel a little worse temporarily. However, the goal is always to get you back to feeling good. It is not uncommon for this to require multiple steps.

Of course, there is also the continued action of the remedies. Although we may seem to be working quickly together, once we complete a session you may also notice that the remedies keep acting.

- **For multiple remedies, the order to take them in is important!**

- **Please do not add any other remedies to the mix while we are working.**

It's no problem to continue with your daily homeopathy plan, but sometimes when people are stressed or desperate they keep searching for remedies even while I am working. Please have patience, continue the process, and we will 'get you there'.

- You may take the remedy as a homeopathic dry dose or wet dose, if you happen to own the remedy already.

- Otherwise, you will broadcast the remedy to yourself using a device. (See above for my preferred devices.) **10 or 11 minutes is the standard run time (depending on the device)**, unless told otherwise. (If you do not have a device, it can be broadcast to you for an additional fee. Refer to the section above.)

Beyond present-day support— *whatever is currently happening for you*— additional days can help you to go deeper to address more underlying/causative layers.

RIGHT TO REFUSE

In rare instances, I might perceive that it would be unwise to offer you *any* remedy options at that time, or I may sense that I would be unable to help you with your situation. In which case, I will let you know, and there will be no charge for any services.

NO GUARANTEES

I will always do my best; but there can be no guarantee of what you will experience, and no specific outcome is ever guaranteed.

PRIVACY

Your information will always remain 100% confidential. The only information I require is name, birthdate, general location and photos. The only specific information transmitted by email from me will be remedy names and potencies. I use a secure email provider (runbox.com). I am not responsible for data collected by gmail or other email services.

Electronic communications will be considered to be in Colorado, where Roaring Fork Homeopathy is based.

CLIENT CONSENT

I understand that you, Sharon Hicks, are an Intuitive Homeopath, and are knowledgeably employing and applying techniques and new strategies pioneered by you, aimed at the alleviation or elimination of acute or chronic disorders by applying homeopathic principles to restore health.

And, that you may be willing to provide me with expert private consultations, specialized information and services related to my own particular health condition, and/or that of my child, family member, pet, or any other subject that we agree to.

I hereby acknowledge and confirm that such services and information as may be provided to me as a result of this request are expressly agreed to be used for my personal and private use and are not to be used for further distribution, and are to be kept strictly confidential, and cannot be misconstrued as medical, dental, chiropractic, veterinary medicine or any other diagnosis, treatment, or advice, or the practice of medicine, chiropractic, dentistry, veterinary medicine or pharmacy, or the manufacturing, marketing or retailing of drugs.

I am fully aware that you, Sharon Hicks, are not professing or holding yourself out to be a licensed medical doctor, physician, chiropractor, dentist, veterinarian,

pharmacist, or any other service provider ‘Qualified’ by ‘Licensure’ under any State of Federal Government law, and that you only charge for the time, care, and expertise necessary for such private consultations.

I also understand that Dawn Spain, if acting as an assistant in my case, is also not not professing or holding herself out to be a licensed medical doctor, physician, chiropractor, dentist, veterinarian, pharmacist, or any other service provider ‘Qualified’ by ‘Licensure’ under any State of Federal Government law, and that she is not offering treatment of any kind.

Additionally, I hereby agree to pay you fully the fees required for such consultation services, at the time services are rendered, and admit that I have not requested such services and information solely for the purposes of ‘inquiry’, but in an honest and legitimate attempt to ascertain the validity of your health strategies for me or my loved ones.

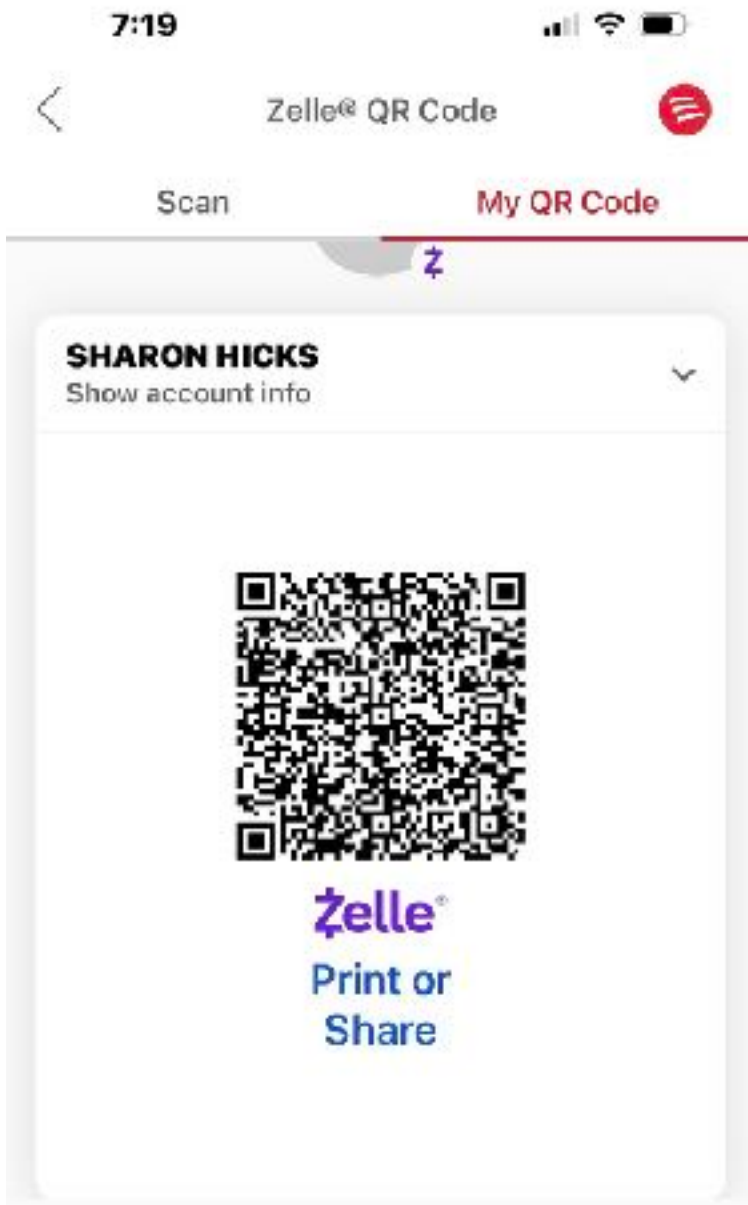
